This editorial presents the articles from the first quarter of the eleventh volume of the Revista Brasileira de Planejamento e Desenvolvimento (RBPD). In this issue, as in the previous ones, the works brought contributions on planning and development, as is usual in this journal.

The first article approaches the present based on the past of Brazilian urban planning in the institutional dimension and its relationship with economic development initiatives. The development of a model for evaluating the legitimacy of integrated municipal plans for the management of civil construction waste is the objective of the second article. Next, an analysis of the deliberative process of the popular consultation is presented for the purpose of structuring part of the annual budget of the state of Rio Grande do Sul for the purpose of investments that promote regional development.

The fourth article is entitled Marco Legal da Urbanização no Brasil: reflexes on the social function of property. The following article provides an opportunity to reflect on regional peripheries through the category of territories of poverty based on rural territories and citizenship. The participation, insurgency and decolonization of urban planning and the university is discussed in the sixth article.

Emphasizing the need for alternatives for economic and financial management in diversified family farming, as well as highlighting the contradictions that the diversification process can bring due to the complexity of carrying out financial controls is dealt with in the seventh article. Next, the analysis of the relative economic dynamism of the municipalities of Ceará that make up the Maciço de Baturité region is presented. The next article presents the analysis of the industrial profile of exports from the Southern Region of Brazil and the hypothesis of deindustrialization.

The tenth article presents the application of the logical framework methodology for tourism planning from a proposal in the municipality of Palmas, Paraná. The penultimate article is entitled The path for the institutionalization of CIM in urban management and planning: a systematic literature review. Finally, the diagnosis of the situation of environmental sanitation in the urban area in the municipality of Portalegre in the state of Rio Grande do Norte (RN) with emphasis

on aspects of sanitary sewage and solid waste management is discussed in the twelfth article.

This edition brings important contributions and reflections on the themes of local and regional development, environmental sanitation, urbanization, investments, the social function of property, regional peripheries, family farming, tourism, economic development, urban management and planning, among others.

We would like to take this opportunity to thank the contribution of all authors and reviewers of our journal.
